  (d) personal property that the Member, the Member's spouse or adult interdependent partner or one of the Member's
- (d) personal property that the Member, the Member's spouse or adult interdependent partner or one of the Member family uses primarily for transportation, household, educational, recreational, social or aesthetic purposes;
- (e) unpaid taxes, except property taxes under the *Municipal Government Act* and taxes under the *School Act*; and
- (f) support obligations.
